The Greenham Earwig Home

There was an earwig in my tent
It was just the other day
It sprang out of my sleeping bag
And I legged it to fetch Kay
She came out in her underwear
Her socks and shorts and vest
And lifted up my bedmat-thats where we found the nest.

I expressed my reservations of where I was to sleep Those insects can get anywhere God knows where they might creep and so I slept in Emmas tent A brand new spacious dome and looked back at my lonely tent The Greenham Earwigs home.

On Nov 25th Roniks and I arrived in Paris to attend and speak at a conference on Nonviolent Resistance for Human Rights Our workshop was Nonviolent Resistance to Nuclear Armament. Also speaking was Solange Fernex from France and Jutta and Volk Volken from the Peace House outside the Pershing base at Mutlangen, West Germany Ronika spoke wonderfully in French (I didn't understand it so I could be wrong). I spoke in English and was translated (wotta wimp). The workshop went well, lots of people came and there was a good debate at the end, though by this time we both were rather out of our depths.

The afternoon session was v. good, except that altho' chaired by a O, the other main participants were man. there were 5 men, from Lebanon, Palestine, South Africa, Uruguay and Bangladesh, speaking about their experiences) - emotionally and informatively about the horrors and traumas they themselves had been through and their countries are continually going through.

They spoke of problems when making alliances with groups not opposed to violence, and the misconception that the term nonviolence means apathy and passivity. They pointed out that for some countries it is impossible to "sit on the fence", for example, in South Africa, white passivity towards apartheid and taking a "neutral position" in reality contributes to apartheid. Tounderstand oppression you must talk to the oppressed not the pppressor!

Most of the speakers were religious and gained strength from their beliefs. The knowledge of what is going on all around you everyday that toucan never be sure that your life is safe, or your family's, is enough to keep you atruggling and gives you

the energy never to give up.

Despite all their harrowing experiences, they remained hopeful and positive, gaining strength from other countries non-violent experiences - both successful and unsuccessful. They got strength and hope from other peoples' personal testimonies and actions. The Palestinian speaker said his strength came from his mother. His father and others were killed, and his mother told him "Do not make orphans and widows by killing".

To see pain and suffering around you causes anguish but also courage. These emotions transmit themselves and strengthen other other people to go on. As the speaker from Uruguay said, It is not possible to be happy when others close by are crying".

Many people sent best wishes and strength to everyone

involved with Greenham.

August dispersal: support vehicles left the base on Aug 8th but by the time the rest of the convoy went out, it was past midnight and therefore Nagasaki day. The Soviet inspection team arrived while it was out, and the convoy returned, after being blockaded at Shrewton to be inspected, on Aug 17th.

September & October on Sept I4th but, probably because of Wilts police being occupied at Stonehenge with Autumn equinox celebrations, it went to Boscombe Down Airbase instead of returning here on the 2Ist, from Bulford Ranges on the Plain (which are very close to Boscombe). The support vehicles did return to Greenham though and were blockaded by wimmin at the Swan roundabout near Grenham.

Support vehicles went out again on 9th October, the convoy moved back to the Plain and the whole lot came back on Oct 16th.

was breached. Strange way to celebrate that event. It went to the Imber ranges. Events on the return journey are on another page. December : barely back from the Nov exercise, the convoy left early in Dec. to get the exercise over in time to get the troops back home for Christmas. OD were very angry to find the USAF sending out a double convoy, i.e. 2 flights, something they haven't done for ages.

The outsize convoy went out as part of a large exercise on the base, in which they were simulating an attack on the base and beinginspected for their operational readiness. The last Operational Readiness Inspection was at the time the INF Treaty was being signed. This time it co-incided with the Bush/ Gorby boat trip when they declared the Cold war over.

Planes did diwes & low flying for 2 days, but we particularly noticed how much attention they paid to the perimeter

On the return QQ once again blockaded supports at the Swan as them is a spot where traffic often has to stop. 5 QQ boarded a Reo carrying camouflage netting & water, climbed onto the roof and covered the wi ndscreen with a banner to make sure it didn't drive off. After IO mins or so sufficient police had mustered to cope. The QQ were not arrested - but there were 2 arrests for obstruction later on. We have never seen a convoy move as fast as that night when the main convoy came back.

There is a rumour circulating that this may have been the last convoy out. Lets hope thats true- what sense is there in

Recent developements at Aldermaston include the announcement that private management will take over the Establishment. There is increasing concern about safety standards under the new regime, especially as they have been dropping in the past year anyway. Aldermaston QQ Campaign has written to the Thames Valley water Authority and to the European Parliament about radioactive waste discharges from Aldermaston, Burghfield and Harwell. This follows measurements at the discharge points by the QQ Boat.

Naomi, over on a visit from Nicaragua, was at the December camp. Camps are still on the second week- end of every month, all

QQ welcome. March 3Ist is Anti- Trident day of action, Aldermaston details to be decided in Jenuary.

Dear Women,

when we first gathered at Greenham, we Knew what we wanted-nucleadisarmament but we didn't know how to get it.

Now we know alot more.

We know that grassroots actions particularly sideways imaginative ones by women, demonsrate to governments the depth of feeling among ordinary people on an issue. Politicians seriously interested in ending the arms race also know that these active women are the tip of the iceburg and that there is underlying widespread support for disarmament.

By making public support for disarmament visible, Greenham women and others have made the political environment in which initiatives and talks can succeed.

However, the underlying causes of aggression, enemy mentality, power greed, racism, repression and injustice have not been addressed politically, except by green parties in Europe and else where. That is why the arms race continues unabated in parralel with reduction talks. The understanding, compassion and strength which led women to take action in the first place was not a shallow thing now lost and gone. This powerful life force continues with a greater political a aware ness gained through our struggle. We are laying the foundations for an interdependent world where mothers do not raise sons to kill and be killedas a method of resolving international disputes.

Such work is long and seemingly slow. But we have a voice disproportionate to our numbers because the whole iceberg supports us. If we give up the iceberg will sink, if we go on it will stop the ship of global destruction in its path. Polititions do not want to self destruct they will twist and turn to suit the climate. And if it is not our iceberg but the economic one which forces the ship to turn back, that is allright for now, because our womens' iceberg will still be ther to block the way forward for the political/industrial/military complex. Now that we know the process for disarmament, we can work for it more; directly rather than randomly, using all the skills we have, in every direction. But our greatest contribution to the future is in building new ways of working, without committees, voting , hierarchies and leaders Every womans voice should be heard. Space must be given to the shy, the less articulate, the unconfident and those of us who talk alot need to shut up and listen! from + more

Nov. IIth 1989: Tory Party Chairman Kenneth Baker was dashing around the Hants/ Berks/ Surrey borders, encouraging the party faithful. Whitchurch was to be the scene of his 'attack on Labour's defence policy' - not difficult for most people! But what he said about Tory policy was interesting.

First he said what defence was for: from foreign offensive and from terrorism. Then a message repeated in different ways:

I) There is a move away from reliance on nuclear deterrence.

2) There is a shift away from heavy reliance on nuclear weapons. Although K. Baker went on quickly to change the subject and say Labour were still unilateralist, it seemed as though he was laying the ground for getting rid of some nuclear weapons. When I asked him about Trident in the light of changes in Europe and the U.S. Congress back-tracking on missile production funding, he replied The U.S. will stand by their obligations to Trident. He didnt sound very confident, probably hoping no-one knew that the British Ambassador to Washington is going round knocking on Senators doors pleading for Trident missiles.

In the corridor afterwards, I asked him if they were really not going to cut the Trident programme and he said 'No'.
'But the U.S. arent going to come up with the goods'.
'Tom King has already made a statement about that'.

'You must be going forward on a wing and a prayer!.

Last September I, along with a friend and her children visited FBlue Gate" at Greenham Common, and I had the happy chance to speak with three comrades who maintained their long and militant vigil. One was Elijabeth another was Georgina, and I can't remember the name of the youngest/one

It was a very special time for me who had followed the struck yes of the women of Greenham Common for nearly ten years! After bringing myself up to date on the situation and learning about some of the small triumphs--which you yourselves described in your bulletin--and some of the difficulties, which are never lacking. I promised to share that wenderfully rich experience with the women from the groups in Penama) in drage To encourage them and to express our mutual solidarity in the struckle for life, which we share even though we are on different continents, separated by an ocean.

The "Jun Mara Embera Crincha Group" is a small group of (Indian women which fights for their daily survival: for a roof, for bread for Their children, for health care which protects a life which, in compagison with other people's, has been disadvantaged from the moment of [ts/barth.] listening once more to the battles of the spirited (combatives) work of Greenham Common, they wanted, through me, to say that they shafe with you the joy of the fight, that they think of you, and that they send you a sisterly embrace. They are also fighting to regain a green and, with trees and streams and clean air, which is the patrimony of everyona: of and women and especially of the first inhabitants of this eath, the indians.

Thank you for your example and for the testimony of your struggle.

What happened at the December 13th Court hearing.

This was the occasion when all the suspended trespass cases would have been up for plea had the House of Lords heard their case and decided against us. That hadn't happened, but the Court had made no attempt to inform all the QQ cocerned that it was not necessary to appear in court on Dec 13th. So some of us did.

Altho' the bye-laws were re-instated in Oct 1988, the Court was

only dealing with trespass cases between Feb and Aug 89. Feb was when the MOD first started using a summons procedure to keep a record of trespasses, Aug was when they gave the first batch of summonses out, mostly to camp QQ. No-one has received any paperwork in respect of incursions since Aug yet.

We were not allowed to plead - 3 new plea dates have been set-21/ 22/ 23 March 1990. We don't yet know if the House of Lords will have done their bit by then or not. Our attempts to get an assurance that cases would be dealt with individually, not in bulk, were not successful. That, we were told, would be for the Court to decide at the time.

We were told unofficially that unheard cases dating from before Feb 89 may be dropped as "stale". By March 1990 a lot more cases could be declared "stale". THAT WOUTDIBE AN EASY WAY OF ERABING YET MORE OF GREENHAM 90'S

Two MOD police arrived in a transit van, picked out Chris from the group, and arrested her for suspician of criminal damagez (yawn). Gould it be What because Chris is usually the smallest she usually gets arrested?


Several wimmin successfully blockaded one of the big Reo trucks by standing accross the road holding banners. Cath climbed up the side and 3 of us scrambled on to the top of the cab. We placed our banners over the windscreen. The mod plods arrived they suggested we would get hurt if we did not come down and would certainly ret arrested. We suggested it was their responsibility not to hurt us if they tried to get us downand certainly they shouln't arrest us. We communicated a little with one of the USAF guys , but hisopinion of us was fairly low-nevermind. Cath was assaulted by a passing ,off duty, abusive, male member of the USAF-no doubt outraged at some wimmin stopping his fellow countrymen protect us from the commies. Well, the MOD arrested him but it didn't take them long to dearrest him again-what can you expect?!!?

After 10 /15 minutes with Emma ,kay and me sitting, standing, waving our banners on top of the stationary Reo, the modplods decided to fairly carefully grab us and carry us down one at a time. Its quite a weird experience to not participate in getting off a high vehicle-allowing yourself, your body to be in the control of policemen who lift you ,pass you put you down-very weird. A bit frightening-a little painful too. Emma, kay and I decided to not co-operate with our arrest so that involved a good deal of being holked out of vans, into vans, out of portakabi ns, into portakabins. As the MOD got more fed up they took less care how they moved us-ouch.

In the portakabins we met Chris who they still hadn't released. We were eventually all let out in time to get freezing cold waiting for the non-arrival of the cruise convoy of launchers and control vehicles, which unusually did not return to greenham that night. Chris was not charged (suprise, suprise). kay. Emma and I were charged with obstructing a police man in the execution of his duty(Funny I thought we obstructed a huge, large truck on a public highway!)

A day trip to Upper Heyford

For a change of scenery, I decided to spend this years Hiroshima da at Upper Heyford. I was not the only one ,as well as the peace campers there were also many people from peace and christian groups and a suprisingly large number of press.

For me, the days thoughts were dominated by the tragic death of Helen Thomas the night before at greenham in addition to the harrowing images this date always provokes. However it was good to be at UpperHeyford and to take part in the actions throughout the day.

After a short service at one gate and a vigil at another, a group of about 9 christians (including a nun and a monk), symbolically chained together, led a prossession along the perimeter fence. Reaching their destination, crosses were attached to the fence and then to the total suprise of the onloking police 9 pairs of boltcutters apeared from under habits, robes, shirts etc... and the fence was well and truly snipped at. The press loved it-nuns cutting fences obviouly makes good coverage and so they pushed and shoved to get the best shots, often hampering the cutt-ers themselves.

The police soon sprung in to action and arrestedthe first few offenders only to find that everyone was chained together and nebody seemed to know who had the key. A wpc sheepishly asked to borrow a pair of boltcutters and cut the chain so she could continue with ner arrest. The 9 cutters were then, very gently, very politely asked to follow the arresting officers into the waiting police van-which they did stopping to do T.V. interviews on the way. The 9 were charged with criminal damage and released a few hours later. The charges have since been dropped and the boltcutters return —ed to their rightful owners.

In the meantime, at another place along the fence a group of people were exercising their right to walk the bridleway which crosses upperheyford base. The case has been to court and been won, so whilst the police were arguing over this with the group trying to get in, we merrily unpicked the fence under their noses and climbed through before they had time to say "we are only our job". Well these poor police boys obviously hannt been very well breifedand were a tiny bit siffed and baffledas everyone poured in after us including the TV cameras and severalnewspaper reporters. If the a bit of a stroll among the bridleway, a few of us were "randomly" abbedo at and ushered into a sherpa. There were 6 of us and we looked at the other and knew each other, we were all greenham wimmin (and one upper and peace camper)—hhhmmm—funny that. We were simply criven round the set the main gate and released so we simply, went back through our looked at another went on... All in all a success fulday was had by all RONIKA.

For those who don't know Naomi; she's an unassuming though brilliant woman , loved by us who knew her when she lived at

Greenham a few years ago.

About 2 yrs ago, she went on a Coffee Picking Brigade to Nicaragua and while there fell in love with the country and the people. She was impressed particularly by the positive attitude of the people there and their determination to survive. After returning to U.K. she took an intensive course and qualified in Primary Health Care, then learned Spanish and any other skills which might best fit her to help in any way she could.

After the Hurricane struck Nicaragua late last year, hardly any news of it was coming through our media. She became desperately anxious about what might be happening to the people there, so, in January this year, Naomi brught a one way ticket, and went/. To us who know and love her it was just as if she had dropped off the odgs of the world and went/

the edge of the world, and we anxiously waited for news.

Since then we have received the most wonderful letters and tapes describing her work, the country and the people. Jill and Jane who have visited her on seperate occasions during the year, have brought back accounts of the amazing ammount of work and

achievements she has accomplished.

Naomi is working in a region called El Cua, which is situated in a mountainous area to the North of Nicaragua. At one time there was virtually nothing there but the Garda post; but after villages and farms, withing a radius of a hundred miles or so, were destroyed by the Contras, and people killed, raped and tortured, the survivors moved to the comparitive safety of 51 Cua.

Jill and Jane have brought back photographs and slides of the Health Centre which serves the area. It is, of course, desperately short of all medial supplies; the treatment room is horryfyingly stark and under-equipped, but nevertheless it is a major achevement

considering the desperately poor circumstances.

Naomi's work includes visiting women, talking and holding workshops to find out what they require, what are their main priorities and what projects they wish to start; then helping them to acheive these. The women said they wanted a library. They were given the use of an old arsenal, and after a lot of very hard work they transformed it; now it is the main centre and meeting place for the people. Here they learn not only how to read but gain all manner of crafts and skills, and information on contraception, water pollution, health care. Jane described the scone beautifully when she spoke of her visit there; a room crammed with groups of all ages, from tiny tots to the elderly, and mentioned a young soldier standing near the doorway deeply absorbed in a book of poems. Naomi has also started a vegetable garden, and is now experimenting

to find which vegetables are best suited to the climate.

There is a wonderful tape from Naomi describing her daily life

and work, which has one dissolving into both laughter and tears. We have started a fund called 'Nicaragua Direct' every penny of which is sent directly to Naomi by courier. Contributors to this can get feed back on what their contributions have helped to acheive.

My first spell in Holloway began on 9th October. As it was for an unpaid fine dating from trespass on the Plain in August 1988 I had had plenty of time to prepare myself. The experience can be mainly summed up in the word "Boring" and as lots of other women know all about it and I wont go into any details about the few days I spent as a guest of H.M. except to say that it was lovely to be greeted by Annabel and Cath. What was different, in my case, was the fact that I was sent down by Witney Magistrates, the fine having been transferred. Witney is on the map mainly as a town where blankets are made; the local police and court have little experience of Greenham Women or peace protesters in Consequently there were some amusing aspects of the situation. Having been found guilty of "wilful refusal to pay the fine" and given seven days, the WPC came forward and led me towards the door leading into the foyer; we emerged, my supporters hugging me and shaking my hand, in an untidy gaggle. The usher asked the wpc where she was taking me and she said "oh, I was just going to walk her to the station" i.e. along the street , past the fire station and in the front door of Whitney nick! The usher suggested the back way was more apropriate sothere we went and I was put into a cell. A young policeman observing my obviously o.a.p. status asked sympathet ically "couln't you pay the fine?" on being told that my refusal like the alledged offence, was an act of conscience, he said "oh, -I see" which he clearly didn't.

After a short while I was put in a car and driven to the police station (all of 200 yards). The seargeant there was surly but the wpc that took charge of me was really nice. She let me take my chocolate and cigarettes into the cell, apologised for removing my lighter and said to call her if I wanted to smoke. She also asked if I wanted lunch. I asked for a vegatarian meal which arrived half an hour later and was delicious. I was also given a cup of coffee and a light for my cigarette when I'd finnished eating. I then arranged a blanket as a pillow and went to sleep. Judth the wpc woke me at about 2.30 and took me to the waiting police CAR the driver was notcommunicative but Judith chatted all the way to London. We were held up in the traffic in the out skirts and when we got through it turned out that neither the driver nor the wpc knew the way to Holloway. I don't Knew Landon well, but I told them I thought it was near camden town. With this info, we eventually arrived. As we stopped at the barriers I remarked "I don't think you'd have got here at all if I hadn't been with you". The driver viewing the massive sliding doors said "Cor, they've got good security here - better than Whitney police station . "So I entered

Holloway on a stifled giggle.
I am relly grateful to Lorna forspending the night with me before the court apearance and telling me just what to expect in prison; to Lorna ,Judith, Jane, and maggie for meeting me on my release, and all the other people who sent cards letters and flowers. If this was meant to be a deterrant it hasn't really worked as I now feel strong enough to face another sentence if neccessary. JEAN-FROM-WHITNEY
